### **Coursing Ability TESTS.**

#### Stakes Offered

These tests are open to hounds at least 12 months of age. The course is a minimum of 600 – yards with a minimum of four (4) turns.

**Coursing Ability Test (CABT)** will be offered with a **limit of 25 entries.** Coursing Ability Tests are open to all dogs at least 12 months of age that are Individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a PurebredAlternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.) Dogs will be inspected prior to any wrapping Being applied to the dog. In the opinion of the inspection committee, any entry found to be lame, unfit to compete or a female in season shall not be allowed to enter and entry fees shall be refunded.
